## **Governors Priorities 2022.23**

In order of precedence, our priorities are to ensure that:

- 1. Supporting the new head teacher
- 2. Statutory requirements are met
- **3.** Students **learn effectively**, so that academic progress from Sept 2022 is as high as possible for all students
- **4.** DfE, WSCC (and similar) **guidelines** are followed, unless there's compelling reason not to.
- 5. The well-being and welfare of pupils and staff is supported strongly
- **6.** Physical **attendance** in school is as high as possible, ensuring that students maximise their time in lessons. Where pupils can't attend, participation in remote learning is as high as possible
- **7.** The activities that were interrupted in last year's **School Development Plan** are evaluated and continue where appropriate
- **8. Governance** improves, specifically "governors hold school leaders to account more effectively" (Ofsted)
- **9.** All reasonable measures are taken to **avoid a financial deficit** (specifically, this and next financial year.
